### Minutes of the 71st Assembly of Delegates

October 12<sup>th</sup>, 2019 / 16:00 at Nosalowy Dwór Resort, Room Rysy 1-4 in Zakopane, Poland

### 1. The President's welcome address

In the name of the ICAR Executive Board the ICAR President welcomes all attendees at 16:15 to the 71<sup>st</sup> ICAR Assembly of Delegates at Nosalowy Dwór Resort in Zakopane, Poland and thanks the local organizing committee for all efforts setting up this year's convention.

The ICAR President personally welcomes the Honorary President Toni Grab and the Honorary Members Dr Hermann Brugger, Nils Farlund, Felix Meier and Dr Ken Zafren.

### 2. Roll call, appointing the officers

We have present:

- 33 A-members with 4 votes each = 132 votes
- 20 B1-members with 2 votes each = 40 votes
- 11 B2-members with 1 vote each = 11 votes

The assembly has a total of 183 votes. The absolute majority (50% + 1 of total available votes) stands at 92 votes.

### 3. Minutes of the 70th Assembly of Delegates 2018 in Chamonix, France

Franz Stämpfli reports: The ICAR Executive Board met for three meetings; in January and in August at Zurich-Airport, Switzerland and in October here in Zakopane, Poland.

- Site inspection for ICAR 2021 in Reichenau an der Rax & Vösendorf, Austria.
- MountainSafety.Info: UIAGM, UIAA, SLF & ICAR basically agreed on the legal entity, but the organization needs to be controlled by these 4 members. This is still the actual situation. We say yes, but we don't want a new big organization.
- Short discussion on the Himalaya issue (big accidents), belongs to UIAA.
- ICAR Commission internal Regulations: The ICAR Bylaws and the ICAR Organization Rules are also the basic commission rules, describing how they work. When creating any further regulations, content collision should be avoided. MED & AIR further developed this issue upon this convention.
- Commission meetings with growing number of attendees (discussion in the commissions).
- Convention Program for this ICAR 2019 Convention in Zakopane, Poland.
- ICAR Association & Congress App.

### 9. General topic 2020

### 10. ICAR Convention 2021 in Vösendorf / Reichenau an der Rax, Austria

The destination has already been approved at the ICAR Assembly of Delegates 2017 in Andorra. A delegation of the ICAR Executive Board and ICAR Office has visited the proposed locations and has found matching and good infrastructure, besides a highly motivated local organizing committee of ÖBRD. ### 12. Statuts/Bylaws

Our current ICAR Bylaws (article 4.3.2) require interpretation clarification. The ICAR Delegates are asked to vote on 2 options.







Odd Staurset (NARG) recommends option 1. Felix Meier (ICAR Honorary Member) explains the original spirit of the bylaws and recommends option 2. The 2/3 majority for bylaws updates is 122. The ICAR Assembly of Delegates decides as follows: Option 1 gets 35 votes and option 2 wins with 140 votes:

"4.3.2 In case of a substitution election during the 4-year term of office, the new member serves for the reminder of the duration of their predecessors. This member can be re-elected twice, which means the term of office commenced is one of the three maximum possible 4-year terms."

# Terrestrial Rescue Commission Report for 2020 and 2021

### Dear Delegates!

Since we did not have an Assembly of Delegates last year, the following is the combined 2020 and 2021 Terrestrial Commission report.

The most important topics over the past two years were:

### Drone Workgroup:

An interdisciplinary drone workgroup has been set up with representative members from all commissions.

Terrestrial Rescue representatives are:
Filip Biocic Croatian Mountain Rescue Service
Jörgen Nordquist, Swedish Police

Drones can be an asset, but they can also be a hazard during rescue operations. The initial draft goals of the ICAR Drone Workgroup are:

- 1. To serve as the main point of contact for ICAR drone issues, with each Technical Commission to identify the scope and breadth of the topics.
- 2. To provide all Technical Commissions with safety guidelines concerning mixed operations of drones and helicopters.
- 3. To identify types of drone applications in SAR, and subject matter experts and specialists in these applications (including such applications as reconnaissance flights, radio relays, and water rescues).
- 4. Other possible goals under consideration include:
  - a. Working with the UAS industry on research and design
  - b. Education on how to establish a program
  - c. Mission examples
  - d. Interfacing with drone regulators

If you have questions or input for this workgroup, please contact our representatives there or contact me by mail or phone.



### Recommendation "Incident command system"

Our TERCOM working group on the "Incident command system" developed a recommendation. This draft was sent out to all delegates earlier this year for your feedback. It is now ready to be a topic at our Assembly of Delegates for voting; we ask all delegates to become informed on the details and consider the contents.

Many thanks to Asgeir Kristinson for his leadership in this working group, along with Alistair Read, Matjaz Serkezi, Dan Hourihan, Kjetil Hoidal, Peter Zimmer and Kirk Mauthner for their input and working together in this working group.

### Virtual Conference (VC) 2020 und 2021

Due to the worldwide Covid 19 pandemic, it was not possible to meet in person at our usual congresses. Instead, to adapt to this situation we organized a virtual congress in 2020 and will again do this for 2021. In the 2020 VC there was high participation from all commissions along with very positive and encouraging feedback. It was a considerable amount of hard work and learning involved to conduct this VC but we were successful and happy that we did it. The minutes from our virtual congress 2020 can be found here:

### ICAR STRATEGIC PLANNING

The ICAR Technical Commission Presidents and Vice Presidents met virtually in mid-April to discuss a number of important topics, including developing an in-depth Strategic Plan for the future of ICAR. The ICAR Executive Board will update ICAR members on its strategic planning thoughts during the upcoming ICAR Online Virtual Congress October 21-23.

### ICAR Homepage

We are working on a new version of our homepage which should give you more support in finding information there and also for a better interchange



of information between the Board, the Commission and their delegates. We hope, that this new version is online by mid-2022.

### **UIAA** Workgroups

Since the last UIAA General Assembly, ICAR is now a member of UIAA. Gebhard Barbisch is now the ICAR delegate in the Safety Commission where they work on new standards and mountain safety related topics.

Gebhard is on a workgroup which is developing a new standard for static ropes. He also participated in a workgroup for "Load sharing devices" and "Avalanche Probes". This has led to the publishing of two new standards for these devices, which can be found by here:

### Development of a mountain rescue system in Kyrgyzstan

Our friends from Kyrgyzstan are trying to increase their level and capabilities of their mountain rescue program so that it is more able to respond to the needs of a modern mountain related tourism industry. ICAR, with their international knowledge and experience, will try to help them.

A lot of smaller tasks and meetings (including board meetings and technical committee meetings) were done over the past two years. Most of them were done by Video Conference and we have learned that a mix of both – video and personal meetings - will be the best to bring our ideas and jobs forward.

Some information about the elections this year:

As known, the ICAR Assembly of Delegates (AoD) is scheduled to take place October 23, 2021 directly after the ICAR Congress. Information from the ICAR Office on the election process will be forthcoming directly to our members. During the AoD there will also take place the election of the Commission presidents. As discussed in our last person in conference in Zakopane and agreed by the commission I will be ready for a re-election. Please note, that this will be the last re-election of me and we will have discuss latest next year in Montreux the way for to go forward in 4 years. Kirk will also be our Vice President for the next 4 years. This was only a decision during our commission meeting in Zakopane because Commission Vice Presidents will not be elected by the AoD.

Despite the difficulties posed by COVID-19 in the last many months, the International Commission for Alpine Rescue ("ICAR") Air Rescue Commission ("AirCom") remained very active in 2021. The AirCom leadership submits the following Annual Report on its activities and strategies during the past several months.

### RENAUD GUILLERMET APPOINTED TO EASA TASK GROUP



ICAR Air Rescue Commission Vice President Renaud Guillermet was appointed to the European Union Aviation Safety Agency (EASA)

"HEMS/ Mountain Rescue Rule Making Task Group (RMT)." The RMT group is led by EASA and a total of seven experts have been appointed for the HEMS/Mountain rescue topic.

In his ICAR AirCom role on the Task Force, Renaud will support EASA with our outstanding worldwide operational expertise. He will be the voice of ICAR with a core knowledge that each program, each region, each country has its own operational challenges.

This special appointment is a direct reflection on Renaud's strong work with EASA leadership. The relationship between ICAR AirCom and EASA has never been stronger, and the EASA appointment of





Renaud is a testament to Renaud's expertise and commitment to the work of EASA. Furthermore, it is also the result of EASA seeing in ICAR a major partner. ICAR's voice counts and you all have contributed to this result.

### Field Study on the Effect of Altitude on Rescue Helicopters Crews.

As a practical case ICAR Air Rescue and Medical Commissions will carry out a "field study" related to the effect of altitude on rescue helicopters crews. AirCom helicopter operators will take the opportunity during training flights to test cognitive capacities of their crews at 4000 m. This field study will complement the one already carried out by our colleagues from MedCom (Dr. Giacomo Strapazzon – Italy) in their hypobaric chamber (Bolzano). EASA is already looking forward to using ICAR's results to validate or amend current regulations.

# INTERDISCIPLINARY "DRONE WORKGROUP"

In 2020, the four ICAR Commissions identified drones as an increasing source of influence on the work of mountain search and rescue, as both an asset and a hazard. As such, ICAR has developed an interdisciplinary "Drone Workgroup" to address all issues pertaining to drones across all four main ICAR Technical Commissions.

The initial draft goals of the ICAR Drone Workgroup are:

- 1. To serve as the main point of contact for ICAR drone issues, with each Technical Commission to identify the scope and breadth of the topics.
- 2. To provide all Technical Commissions with safety guidelines concerning mixed operations of drones and helicopters.
- 3. To identify types of drone applications in SAR, and subject matter experts and specialists in these applications (including such applications as reconnaissance flights, radio relays, and water rescues).





Other possible goals under consideration include:

- 1. Working with the UAS industry on research and design
- 2. Education on how to establish a program
- 3. Mission examples
- 4. Interfacing with drone regulators

The issue of drones in search and rescue is a broad and complicated one, and the workgroup is working to identify which issues to address first. For any thoughts on drones in SAR, or to report advances or concerns related to drones, please contact Renaud Guillermet.



# INCIDENTS AND ACCIDENTS REPORTING

One of the hallmarks of the ICAR Air Rescue commission is our recording and reporting on incidents and accidents in helicopter rescue operations (including both HEMS and HEC operations). We report on these in detailed sessions at our annual Congress events and our new AirCom Spring Meetings, and we depend on ICAR members and colleagues to submit incident and accident reports

Of particular note in the 2021 AirCom study are the following types of incidents and accidents:

- Inadvertent Instrument Meteorological Conditions (IIMC) resulting in Controlled Flight Into Terrain (CFIT)
- Inadvertent Human External Cargo (HEC) resulting in the unintended raising of ground personnel during a hoist or short haul HEC operation
- Wake Turbulence left behind a helicopter flight resulting in unstable air mass that could affect
  the subsequent flight of hanggliders and parasailers into the path of the wake turbulence.

It is very important that ICAR AirCom delegates and colleagues report on any current incidents, accidents, or final reports that can be of value to the AirCom community. Please consider if there have been any incidents or accidents in your region, and report them to Charley Shimanski or Renaud Guillermet.





### ICAR STRATEGIC PLANNING

The ICAR Technical Commission Presidents and Vice Presidents met virtually in mid-April to discuss a number of important topics, including developing an in-depth Strategic Plan for the future of ICAR. Terrestrial Commission President Gebhard Barbisch led a discussion about issues facing ICAR, including growth in membership and growth in attendance at in-person Congress events. The ICAR Commission leadership conducted a few more virtual



meetings on the topic of a Strategic Plan, and the ICAR Executive Board met in Zurich to further discuss a plan.

Air Rescue Commission President Charley Shimanski is leading efforts to develop a Strategic Framework to guide this strategic plan. Furthermore, the ICAR Executive Board will update ICAR members on its strategic planning thoughts during the upcoming ICAR Online Virtual Congress October 21-23.

### ICAR-MED 2020-21 Annual Report (2 years)

### Dear colleagues

This is my 3rd 'annual' report though the 4th year of my presidency. Covid-19 has been responsible for this slight - in the light of its other effects - change in normality. Medcom members have been at the heart of the Covid-19 response. Indeed our colleagues around Lecco, Italy and the Dolomites were some of the first to see the devastation brought by this virus. I can only admire and revel at the fortitude and resilience of my members as they put patients first at a time when our knowledge was primitive and the consequences so severe.

Our discussions in my last annual report about numbers of participants at meetings seems out-of-place now. Zakopane was our last meeting in person, and that seems an aeon ago. Meetings in New Zealand, Greece, Scotland; and rearranged Greece have all be cancelled. Ironically my last annual report said we had started video conferencing in 2019; we now 'experts' at this form of communication, though it is clear it cannot completely replace being together when we are trying to find common ground for our recommendations and guidelines.

During the last two years we have managed to publish a number of papers and have agreed new recommendations. Details of these developments can be seen on our dedicated website – <a href="http://www.icar-med.com">http://www.icar-med.com</a>. We have encouraged and supported Covid-19 information for rescue teams and have used ICAR funds (the MedCom budget) to publish a couple of open access articles. To complete the recommendation's cycle, we are presenting three MedCom recommendations to the Assembly of Delegates 2021 for approval as ICAR recommendations. Ongoing work to update our older recommendations continues with both termination of CPR and the medical aspects of avalanche rescue being actively discussed on our forum. The Diploma in Mountain Medicine has largely been moth-balled during the period though a development day was run virtually by Jason Williams in conjunction with the International Society of Mountain Medicine and the UIAA MedCom.

My two Vice Presidents, Natalie Hölzl and Alison Sheets, have supported the MedCom and we have a good team keeping the administration going.





All this activity however can not disguise our feelings of loss at not meeting face-to-face, and the anxieties of what it will look like when we do get together again. At present we are optimistic that our Spring meeting 2022 in Boulder, Colorado will go ahead and we be able to rekindle a reconnection and the vigour of the MedCom.

On a personal note, I would normally have encouraged the MedCom to discuss whether they wished to extend my term of office as President for a further 4 years this October. In absence of a face to face meetings of a significant number of the MedCom delegates this is waiting for Switzerland 2022.







Dear ICAR Members,

On behalf of HRT, we send you our regards and wishes for a successful assembly.

As most of you might remember, in the last conference, held in Poland, HRT proudly announced that it will host the ICAR 2020 congress for the first time in Thessaloniki, Greece. Hosting the conference has been a long-term ambition for our organization, since mountain rescue has been the core of our voluntary action for more than 20 years. More than 10 HRT volunteers and staff became fully engaged in organizing a competent conference and, in that frame, we proceeded, with the implicit support of Tom Spycher and in cooperation with our PCO, Erasmus, with the implementation of all the necessary actions (booking the venue, creating a website, contacting potential sponsors, ect).

# Statutes updates - explanation

## To be voted upon during the 2021 virtual Assembly of Delegates

Dear ICAR Delegates,

Dog Handlers are an integral part of ICAR since long ago. The work of the Dog Handlers sub-commission has increased over the years and requires an adaptation of the ICAR Statutes to ensure a smooth operation of the Dog handlers sub-commission.

In Borovets (Bulgaria, 2016) the ICAR Board reached an agreement that Dog handlers sub-commission President should sit on the Technical Committee of the Board, assists to board meetings, participates in discussion, but does not have voting rights.

Since 2016, the ICAR Board has been talking about the Dog-handler sub-commission involvement, made various proposals, without, however, being able to present a final solution to the ICAR members.

In 2020, after various ICAR Board meetings, the ICAR board finally came to an agreement and is now ready to present their solution to the Assembly of Delegates for approval.

In view of the great involvement of the Dog handlers sub-commission President on the ICAR Board, we propose that the Dog handlers sub-commission President has the same responsibilities, rights and duties as any other President of a technical Commission.

This change cannot happen, however, without the ICAR Bylaws being updated and these updates being approved by the Assembly of Delegates.

The proposed updates are clearly marked in yellow in the text of the attached file "ICAR-Bylaws-changes \_DOG-SUB-2021.pdf".

The ICAR Organizations rules also need to be updated accordingly and changes are highlighted in yellow in the attached file "ICAR-Organization-rules-changes-DOB-SUB-2021".

We are kindly asking the delegates of the ICAR member organizations to support this proposal and vote in favor of these amendments to the documents.

# **ICAR Organization Rules**

20211023-ICAR-Organization-Rules (unchanged text, new text)

#### 1 Purpose

The organization rules state the organization, tasks, procedures and authorizations of the board, the technical commissions, and the ICAR office in order to facilitate efficient operation.

#### 2 Basics

The rules are based on the ICAR statutes, in particular on sections 4.3, 4.5, 5 and 6.

#### 3 Scope

The rules apply to the activities of the board, the technical commissions, and the ICAR office.

## 4 The Board

#### 4.1 Organization

The organization of the board is laid down in section 4.3 of the ICAR statutes.

#### 4.2 Management Rules

- 4.2.1 The leading process is established on a management circle. This management circle is related on a core competence based on strategy and its goals. The circle includes the following process:
  - 1. Orientation & Identification
  - 2. Analyse & Assessment
  - 3. Decision
  - 4. Planning
  - Execution & Benefit
  - 6. Evaluation
  - 7. Orientation & Identification
- 4.2.2 The board members take care of their duties free of charge and autonomously. Special attention must be paid to the flow of information within the board and to the member nations.



- 4.2.3 Contact with organizations that are not members of ICAR require the involvement and approval of the president.
- 4.2.4 Time limits on assigned tasks are to be respected.

## 4.3 Tasks and Responsibilities

#### 4.3.1 The President

- represents ICAR to the outside world;
- manages and coordinates the business of ICAR and the board and is responsible for orderly procedures;
- runs the board meetings and the assembly of delegates and issues the invitations with a list of the issues to be scheduled;
- prepares the annual report of ICAR for the assembly of delegates;
- assigns specific tasks to board members;
- supervises the work of the ICAR office in all respects except accounting.

#### 4.3.2 The Vice President

replaces the president if absent; - assumes special tasks and duties.

#### 4.3.3 The Treasurer

- is responsible for accounting and investments;
- supervises the accounting by the office of ICAR;
- prepares the annual financial report and the budget for the assembly of delegates; monitors adherence to the budget.
- 4.3.4 The Presidents of the Technical Commissions and Sub-commission
  - are responsible for the management of their commission or subcommission in accordance with the rules;
  - implement the board decisions within their commissions or sub-commission;
  - inform the president about their intentions, goals and activities;
  - manage the commission or sub-commission work and foster the contact among commission or sub-commission members throughout the year.

#### 4.3.5 The Assessors

- perform special tasks and duties:
- bring new insight and experience from their organization to the board level; process applications for membership on behalf of the board.

#### 4.4 Board Meetings

- 4.4.1 As a rule, there are two board meetings per year, one in the spring and one in the fall, the latter preceding the assembly of delegates.
- 4.4.2 The president invites the board members in a timely manner, at least one month in advance and prepares a list of the issues to be discussed.



- 4.4.3 The spring meeting venue is near a central location for all board members.
- 4.4.4 For urgent matters or special issues, the president may request individual members to attend a meeting.
- 4.4.5 Board meetings are conducted in English or another common language, as decided by the board.
- 4.4.6 Minutes shall be taken of the board meetings. The minutes shall be distributed to the board members in English.
- 4.4.7 All board members are entitled to vote. In case of an equal number of votes, the president's vote counts double.

#### 4.5 Authorities of Board Members

- 4.5.1 Legally binding documents of ICAR or documents of particular importance must be signed by the president and one more board member.
- 4.5.2 Documents not covered by the above may be signed by the respective board member on their own responsibility. Other board members are to be informed as appropriate.

#### 4.6 Financial Matters

- 4.6.1 Expenses arising from the board member's duties are compensated by ICAR. The details are laid down in the expenses rules of Oct. 12, 2010.
- 4.6.2 Expenses must be claimed from the treasurer by November 30 of the current year at the latest.
- 4.6.3 It is in the interest of ICAR to keep expenses low.
- 4.6.4 Expenses that have been budgeted can be decided upon by the board.

#### **5 Authority**

#### 5.1 Board Members

5.1.1 Board members may authorize all expenses that are within the framework as set by the statutes and/or by the decisions of the assembly of delegates by two, except for their own expenses.

#### 5.2 Office Manager

5.2.1 The office manager may authorize by two all expenses that have been approved previously by either the board of by the assembly of delegates.





#### **6 The Technical Commissions**

#### 6.1 Purpose

Mountain rescue technical tasks and problems are handled by the technical commissions.

#### 6.2 Basics

The rules are based on the ICAR statutes, in particular on sections 2, 4.1, 4.5, 5.2 and 6.

#### 6.3 Tasks

- 6.3.1 Presentation of mountain rescue equipment and accessories
- 6.3.2 Technical assessment and safety check of the presented equipment and preparation of recommendations and proposals for improvement
- 6.3.3 Evaluation of mountain accidents, accident research, prevention of mountain accidents and preparation of statistics
- 6.3.4 Preparation of medical recommendations for primary care and transportation of injured or sick patients in the mountains
- 6.3.5 Exchange of technical experience and know-how and exchange of respective documentation
- 6.3.6 Dissemination of information about mountain rescue and for the prevention of mountain accidents

#### 6.4 Organization

- 6.4.1 Four technical commissions and one sub-commission handle the areas of
  - terrestrial rescue
  - avalanche rescue
  - air rescue
  - mountain emergency medicine
  - dog handlers
- 6.4.2 The presidents of the technical commissions or sub-commission are members of the ICAR board. Knowledge of a second language is preferred.
- 6.4.3 The members of the technical commissions or sub-commission shall be active and experienced specialists in the respective domain of mountain rescue or shall be able to influence mountain rescue based on their professional activity. Good language abilities are desired and are advantageous to the work of the commissions.
- 6.4.4 The commission or sub-commission members are nominated by their organizations. They must be able to attend the meetings.
- 6.4.5 Commission or sub-commission members are delegated for a period of four years (normal period of office). In order to ensure continuous work, replacing commission members should only be done in exceptional circumstances.



6.4.6 The number of members of a technical commission or sub-commission shall be limited in order to enable efficient work.

#### 6.5 Procedures

- 6.5.1 At least once per year, the technical commissions or sub-commission are required to organize a workshop day; usually preceding the assembly of delegates. The program (activities and goals) including appendices shall be distributed to all members at least 30 days before the meeting.
- 6.5.2 Additional workshops during the year are desirable. Contacts and exchange among commission or sub-commission members shall also be fostered between the meetings.
- 6.5.3 Special attention must be paid to the flow of information among the technical commissions or sub-commission. Issues must be constantly monitored for relevance to other entities.
- 6.5.4 If an issue spans the domain of multiple technical commissions and subcommission, the commission responsible for management must be defined.
- 6.5.5 Minutes and a list of participants shall be prepared for every workshop and meeting.
- 6.5.6 The technical commissions or sub-commission conduct a common meeting in the framework of the assembly of delegates. The meeting is run by the ICAR president. The commission or sub-commission presidents present a short report about their activities and communicate their goals for the year to come.
- 6.5.7 The meetings are conducted in at least two of the ICAR languages. The commission or sub-commission presidents are responsible for interpreters.

#### 6.6 Responsibilities, Rights and Duties of the Members

- 6.6.1 Based on a proposal from the commission, the assembly of delegates elects the commission and sub-commission presidents.
- 6.6.2 For elections and voting, the organizations that are represented in the commissions or sub-commission have one vote each. The president is also entitled to one vote. In case of an equal numbers of votes, his vote counts double.
- 6.6.3 Personal insights, development, training material and publications are to be made available to ICAR.





6.6.4 The members of the technical commissions or sub-commission are required to disseminate recommendations from ICAR or from the technical commissions or sub-commission within their own organizations.

#### 6.7 Financial Matters

- 6.7.1 The expenses resulting from the participation in the technical commissions or subcommission are taken care of by the member's home organization.
- 6.7.2 The presidents may spend an amount that is defined by the assembly of delegates on expenses and administration. Expenses must be claimed until November 30 of the current year at the latest.

#### 6.8 Authorities

- 6.8.1 The technical commissions or sub-commission raise mountain rescue issues on their own initiative. The board must be informed.
- 6.8.2 If necessary, the technical commissions or sub-commission may extend the current set of rules by other, commission or sub-commission specific items in an appendix to this document.
- 6.8.3 Requests for modifications and extensions to the present rules must be submitted to the board by the commissions or sub-commission.

### 7 The Office

- 7.1.1 The daily business of ICAR is taken care of by an office.
- 7.1.2 The president and the treasurer supervise the office's activities.
- 7.1.3 The relationship between ICAR and the office is defined in a separate contract.
- 7.1.4 The duties of the office are defined in an appendix to the contract.

#### 8 Various

8.1.1 Changes to this document that do not interfere with the statutes may be decided upon by the board on its own.

The present rules replace the rules for the board of Oct. 2<sup>nd</sup>, 2007 and the rules for the technical commissions of Oct. 1<sup>st</sup>, 1994. They have been approved by the assembly of delegates of 2013 in Bol. They have been approved by the virtual assembly of delegates of 2021.

# **Statutes**

## 20211023-ICAR Bylaws (unchanged text, new text)

#### 1. Name/Head Office

- 1.1 The International Commission for Alpine Rescue is a co-operative association of organizations and societies - called "Members" in these statutes - who are either active leaders in mountain rescue or, owing to their purpose, are interested in efficient mountain rescue.
- 1.2 ICAR is neutral with regard to political and religious beliefs. It is incorporated as an association under Swiss law. Its seat is in 8302 Kloten, Switzerland. The court of jurisdiction is where ICAR is seated.

## 2. Purpose/Tasks

- 2.1 ICAR works as worldwide open platform for the exchange of mountain rescue knowledge. Terrestrial rescue, avalanche rescue, alpine air rescue and alpine emergency medicine are part of mountain rescue (includes prevention).
- 2.2 In particular, ICAR has stipulated the following tasks:
  - 2.2.1 The main task of ICAR is the exchange of experience between the practitioners in mountain rescue.
  - 2.2.2 ICAR is a technical forum for new insights in mountain rescue.
  - 2.2.3 ICAR is a safety forum for mountain rescue.
  - 2.2.4 ICAR issues recommendations to its members about mountain rescue and the prevention of accidents.
  - 2.2.5 ICAR represents the interests of its members to other organizations at an international level and, upon request, at a national level.





- 2.2.6 ICAR cultivates the exchange of knowledge with the manufacturers of equipment relevant to mountain rescue.
- 2.3 ICAR is not pursuing any commercial purposes and is not profit oriented.

#### 3. Membership

- 3.1 ICAR consists of the following member categories:
  - Member A: Rescue organizations of a Nation or of national importance\* who cover all the aspects of mountain rescue and fulfil recommendations set out by the ICAR Assembly of Delegates.
  - Member B1: Rescue organizations of regional importance including alpine associations\*\* and organizations who cover part of the aspects of organized mountain rescue. They should fulfil recommendations set out by the ICAR Assembly of Delegates.
  - Member B2: Subject specific organizations who cover part of the aspects of mountain rescue. Their rescue activities should fulfil recommendations set out by the ICAR Assembly of Delegates.
  - Member C: Organizations within the field of mountain rescue who are not directly
    active in the ICAR and organizations that aspire to be members who cannot
    currently meet the guidelines for A or B membership. Their rescue activities should
    fulfil recommendations set out by the ICAR Assembly of Delegates.
  - Member D: ICAR Honorary Members, see paragraph 3.3.
  - Member E: Organizations, with no organized mountain rescue mission, who support ICAR goals.
  - \* National importance is determined by a relationship with the national government which states the organization will be called upon in national need.
  - \*\* An alpine association that maintains an organized mountain rescue component within their membership.

#### 3.2 Admission

- 3.2.1 Applications for admission into ICAR by organizations are to be addressed to the ICAR President. Published recommendations of the ICAR Assembly of Delegates regarding ICAR membership need to be observed. When processing membership applications, the ICAR Executive Board consults the ICAR Members from the country of origin. The admission of category A, B1 or B2 Members takes place at the request of the ICAR Executive Board through the ICAR Assembly of Delegates.
- 3.2.2 The ICAR Executive Board decides on admission for Members of category C or E.

#### 3.3 Honorary Members

A person of special merit with regard to ICAR may be nominated as an Honorary Member or Honorary President by the ICAR Assembly of Delegates.





#### 3.4 Rights of the Members

- 3.4.1 The Members of category A and B1 or B2 are entitled to vote at the ICAR Assembly of Delegates.
- 3.4.2 Members of category A have four votes each, Members of category B1 have two votes and Members of category B2 have one vote. Members of category C, D and E do not have voting rights.
- 3.4.3 The Honorary Members may participate in all ICAR meetings.

#### 3.5 Duties of the Members

The Members have the duty:

- 3.5.1 To introduce their own experiences and knowledge, developments and innovations, and statistical mountain rescue data to ICAR.
- 3.5.2 To make information from ICAR and its commissions available to their organizations.
- 3.5.3 To pay their annual fees by June 30th according to the resolution passed by the Assembly of Delegates.
- 3.5.4 To declare the potential of financial or commercial gain and abstain from voting on any ICAR decision that may be beneficial to them.

#### 3.6 Termination of Membership

- 3.6.1 Membership ceases immediately upon receipt of a resignation in writing. The fee for the current year, however, would still have to be paid.
- 3.6.2 In cases of serious violations of duties, non-payment of the annual fees for two years, damage to the reputation of, or obvious lack of interest in the activity of ICAR, the Assembly of Delegates upon proposal of the Executive Board may terminate a membership.

#### 4. Organization

#### 4.1 Bodies of ICAR:

- Assembly of Delegates (AoD)
- Executive Board (BOA)
- Technical Committees (TER, AVA, AIR, MED, DOG)
- Auditors (AUD)

#### 4.2 Assembly of Delegates (AoD)

- 4.2.1 The Assembly of Delegates is the supreme authority of ICAR. It convenes annually at the invitation of the President.
- 4.2.2 The invitation to the Assembly of Delegates must be published on the ICAR website together with the full agenda at least one month prior to the Assembly.



- 4.2.3 Members' motions for the agenda must be submitted in writing to the President at least three months prior to the Assembly. Nominations for elections must be submitted by the Member organizations in writing to the President at least three months prior to the Assembly. Members' motions and nominations may also be brought forward at the opening of the Assembly. The Assembly of Delegates approves admission of such motions and nominations.
- 4.2.4 An extraordinary Assembly of Delegates may be convened upon the request of a minimum of one fifth of the voting members or the Executive Board. The invitation including agenda is sent out at least two months ahead of time.
- 4.2.5 The official languages of ICAR are German, French and English.
- 4.2.6 By rotation of country, Members make themselves available for the organization of the annual Assembly of Delegates.
- 4.2.7 Business of the Assembly of Delegates is:
  - to elect the president, the other members of the Executive Board, and the Auditors
  - to approve the annual report of the President
  - to approve the minutes of the last Assembly of Delegates
  - to approve the annual financial statement and the report of the Auditors
  - to approve the budget for the next fiscal year
  - to approve the expense regulations for the Executive Board
  - to vote on the admittance and expulsion of Members
  - to elect Honorary Members
  - to determine the activities of ICAR for a coming period of time
  - to determine the amount of the member fees
  - to decide on business, that is proposed by the Executive Board
  - to decide on the location and time of the next Assembly of Delegates
  - to decide on changes of the statutes
  - to decide on the dissolution of ICAR

#### 4.3 The Executive Board (BOA)

- 4.3.1 Executive Board members are nominated by an ICAR Member organization.

  The Assembly of Delegates elects the Executive Board for a four-year period.

  Members may be re-elected twice for the same role. If an Executive Board member takes on a new role, the four-year period starts anew.
- 4.3.2 In case of a substitution election during the 4-year term of office, the new member serves for the reminder of the duration of their predecessors. This member can be re-elected twice, which means the term of office commenced is one of the three maximum possible 4-year terms.
- 4.3.3 The Executive Board consists of the President, Vice-President, Treasurer, the Chairmen of the technical committees and up to 5 assessors. The Executive Board members are elected as individuals and for a specific role.
- 4.3.4 The Executive Board carries out its assigned duties and work according to its own business agenda.





- 4.3.5 The Executive Board is responsible for all business that is not assigned to other bodies (i.e. approval of recommendations from the technical committees).
- 4.3.6 The Executive Board members do their work on a voluntary basis and do not get any compensation except for the reimbursement of direct expenses.

  Exceptional contributions of individual Executive Board members may receive a reasonable compensation.
- 4.3.7 The organization of the duties of the ICAR Executive Board is defined in a separate document (ICAR Organization Rules).

#### 4.4 The President

The President represents ICAR externally. He is responsible for the normal conduct of business. He has the authorized legal signature for ICAR jointly with another Executive Board member.

#### 4.5 The Technical Committees

- 4.5.1 The technical committees deal with their own responsible areas. These are:
  - Terrestrial Rescue Commission (TER)
  - Avalanche Rescue Commission (AVA)
  - Air Rescue Commission (AIR)
  - Alpine Emergency Medicine Commission (MED)
  - Dog Handlers Sub-commission (DOG)
- 4.5.2 In order to deal with new fields of interest in the mountain rescue sector, the Executive Board can set up additional commissions or working groups. The Executive Board regulates the working groups' tasks, time frames, their compositions and authorities.
- 4.5.3 The number of members of the technical committees shall be only as large as necessary to enable efficient work.
- 4.5.4 The ICAR Organization Rules define their tasks, procedures, composition and authority.

#### 4.6 Auditors (AUD)

- 4.6.1 The Assembly of Delegates elects two Auditors for a period of four years.

  Auditors may be re-elected twice. The elections are held at the same time as the elections of the Executive Board members.
- 4.6.2 The Auditors must be representatives of a Member organization, but may not belong to the Executive Board.
- 4.6.3 The Auditors inspect the annual financial statement according to the rules of revision and auditing schedule and make recommendations to the Assembly of Delegates.

#### 4.7 Office

The ICAR office takes care of regular operations. It is subordinated to the president of ICAR. Its tasks are defined in a contract.

#### 5. Quorum, Right to Vote, Method of Voting

5.1 The Assembly of Delegates and the technical committees constitute a quorum, if at least half of the members entitled to vote are present.

#### 5.2 Entitled to vote:

- at the Assembly of Delegates: The delegate of a categories A, B1 or B2 Member
- at the Executive Board: All Executive Board members
- at the Technical Committees: The respective Chairmen and the special delegates from the Member organizations identical to the votes at the Assembly of Delegates
- 5.3 The voting and elections are usually open. Upon the request of a delegate with the right to vote, the Assembly of Delegates may decide to vote or hold an election by secret ballot.
- 5.4 On voting matters, other than election of persons, and subject to the provisions of section 7.1 of these statutes, the results are determined by a simple majority of the given, valid votes. In case of a tie, the Chairman's vote decides.
- 5.5 In elections of persons, the absolute majority determines the result in the first round, and the simple majority of the valid votes in the second round.
- 5.6 Voting and election rights can only be exercised through presence.

#### 6. Finances

- 6.1 The expenses of the delegates at ICAR meetings shall be covered by the Member organizations and associations to which they belong. If needed, the Executive Board may approve exceptions.
- 6.2 Expenses of the Executive Board members at ICAR meetings and their budgeting shall be regulated in an expense regulation. These regulations have to be approved by the Assembly of Delegates.
- 6.3 The ICAR treasury shall cover expenses that result from the conduct of business.
- 6.4 ICAR pays a maximum amount, which is determined annually, toward the administrative expenses of the Chairmen of the technical committees.
- 6.5 The liability of ICAR is limited to the liability of the association according to Swiss law.
- 6.6 The fiscal year for ICAR is identical to the calendar year.





#### 7. Concluding Regulations

- 7.1 The following resolutions of the Assembly of Delegates require a qualified majority of the members who are entitled to vote:
  - Amendments of the statutes: 2/3 majority
  - · Dissolution of ICAR: 3/4 majority
- 7.2 After the dissolution of ICAR the remaining assets are to be bestowed on tax-exempt institutions with purposes of the same or similar kind.
- 7.3 Unless the statutes rule differently, the laws of the country in which ICAR has its seat apply.
- 7.4 The statutes are written in German, French, and English; in cases of doubt, the German text is paramount.

# Recommendation – Incident Command System (ICS)

TER-REC000x / Commission for Terrestrial Rescue

#### 1. Introduction

A suitable command structure is required in every rescue operation. Most rescues in an alpine environment are done by one or a few local rescue teams who have a good understanding of each team's systems and capabilities. They often train together and coordinate with each other. In such situations, often the command structure is informal, simple and based upon the needs of the situation. This is normal and understandable, but still a structure exists.

Although most alpine operations are small in scale, larger incidents are possible, with many moving parts both at and away from the rescue site. This type of incident may even involve more than one country. This calls for a more complex command structure, which rescue teams have to be able to adapt to.

It is important to use a command system that is flexible, cabable of scaling from the smallest size to larger multi-agency incidents.

#### 2. Recommendation

#### Incident command system should be:

- 1. Scalable and modular: easily support the incident command team from 1 person to a large group.
- 2. Usable for small scale local incidents to a large disaster stretching between communities or countries without the need to change the system.
- 3. Standardized structure and terms.
- 4. Workable in all environments.
- 5. Integrated into national incident command system.
- 6. Able to allow timely transmission of data and personal information under the laws of each country.



#### 3. Explanatory notes

- 1. **Scalable and Modular**: It is very important not to change the system due expanded incident needs.
- 2. **Usable for all scenarios**: As features expand, it is important that everyone understands the system and can merge directly into it.
- 3. **Standardized**: Structure and terms that everyone is familiar with and trained in.
- 4. Workable in all environments: On land, at sea and in the air.
- 5. Integrated: Into national incident command system.
- 6. **Integrated Communications:** Able to allow timely transmission of data and personal information under the laws of each country.

#### 4. Glossary

Incident	An occurrence that needs a response from one or more agencies/jurisdictions. It may or may not be an emergency.
Command	Command operates vertically within an agency. It describes the internal ownership, administrative responsibility, and detailed direction of an agency's personnel and resources. Command cannot normally be exercised outside of an agency, without delegation of authority.
System	A structure used to organize the response to an incident.
Team	A group of rescue persons, never exceeding eight including one leader, working for the same goal on a callout.
Standardized	The same word for structures and terms.
Scalable	One person to multiple jurisdictions.
Modular	Expandable to different system components based on the needs of the incident.

## Draft ICAR Guidelines for Mountain Rescue during the COVID-19 Pandemic

## Official Guidelines of ICAR

### **Rescuer Summary**

The ICAR Guidelines for Mountain Rescue during the COVID-19 Pandemic covers several important topics pertaining to mountain rescue:

This document is a plain language summary of key 'take-aways' from the ICAR MedCom guidelines. The full MedCom paper has been published in High Altitude Medicine and Biology, and should be referred to for more detail and explanation. This is available as an open access article; a link can be found at <a href="http://www.icar-med.com">http://www.icar-med.com</a>.

A significant issue during the pandemic has been the speed that the virus has spread and the evidence-base on how to deal with it. The accompanying national and regional regulation changes have been equally rapid and rarely had chance to consider the special circumstances of mountain rescue. Hence the following sentiment from a professional rescuer:

"We need to be careful that we are not just moving risk around if the true goal is to reduce the risk. Wearing masks, gloves and full personal protective equipment (PPE) in technical terrain creates its own hazards. It may reduce the potential for a COVID-19 exposure but the potential for a fall or mistake in technical terrain is increased."

The recommendations are in bold and are followed by a strength grading that is explained at the end of this document.

The risk of contracting COVID-19 outdoors is low when rescuers are careful and follow hand washing and social distancing measures. Increasing levels of protection should be instigated before you are in close contact with patients and other rescuers. During technical rescue activities, PPE may introduce additional risk as a result of unacceptable communication or visibility. Limits on exertion and performance can impair a rescue. In this way, COVID-19 precautions may complicate, distract from or increase some risks of mountain rescue.



#### Recommendation 1

Mountain Rescuers must maintain situational awareness by identifying and managing the risks of exposure to COVID-19 during mountain rescue in the context of the general risks of mountain rescue. (1C)

#### Recommendation 2

Any mountain rescuer that is ill with symptoms of COVID-19, or has been advised to self-isolate following a positive COVID-19 test or through contact tracing, must not respond to missions and must not participate in training exercises. (1C)

#### Recommendation 3

Mountain rescuers should be trained in the selection, putting on ('donning') and removing ('doffing') of appropriate PPE. Refreshing, updating and alternative techniques should be considered to encourage continued compliance with the recommendations. (2C)

#### Recommendation 4

Mountain rescuers should follow appropriate national, regional and organisational instruction on the wearing of face coverings. Outdoors, a medical grade surgical mask covering mouth and nose should be worn whenever there is close contact (≤ 2 meters) with other rescuers or patients, with the proviso that it does not introduce other unacceptable safety risks. (1A)

#### Recommendation 5

A surgical mask should be placed on the patient immediately upon contact and kept in place throughout the rescue and evacuation. An oxygen mask can be placed on top of this. (2C)

#### Recommendation 6

Mountain rescuers that may be involved in close contact with patients during first aid and medical procedures should don PPE before encroaching within 2 meters of the patient. They should wear masks with N95/FFP2 or higher ratings. (1A) They must wear eye protection and waterproof medical grade gloves. (1C)

#### Recommendation 7

Water resistant masks should be considered in some environments and wet masks should be changed as soon as possible. (2C)



#### Recommendation 8

Hand washing must be performed before donning and after doffing PPE; before and after patient care, before and after eating or touching one's face, after blowing your nose, coughing, or sneezing, and after cleaning or disinfecting equipment. If soap and water are not readily available, use a hand sanitizer that contains at least 70% alcohol. (1C)

#### Recommendation 9

Potentially contaminated rescue and personal equipment must be cleaned with soap and water, 70% isopropyl alcohol, or viricidal agent. The manufacturer's instructions should be followed to avoid damage to the material. (1C) If cleaning is not possible, the equipment can be quarantined for a minimum of 72 hrs or disposed in an appropriate way. (2C)

#### Recommendation 10

COVID-19 vaccination is recommended for eligible mountain rescuers. (1A) Vaccination may not not remove the need for the precautions recommended above. (2C)

#### Recommendation 11

Mountain rescue teams should encourage and promote communication and training activities that address rescuer stress and promote psychological resilience. (2C)

#### Recommendation 12

Mountain Rescue Organisations may need to adjust their first aid and medical advice in order to minimising the chance of COVID-19 transmission. Any changes must be clearly communicated in a timely fashion to rescuers. Support and training should be given, especially when long-held practices (for example, in CPR) are modified. (2C)

#### DRAFT ICAR RECOMMENDATION - RESCUER SUMMARY

Clinical staging of accidental hypothermia is used to guide out-of-hospital treatment and transport decisions. Most clinical systems utilise core temperature, by measurement or estimation, to stage hypothermia, despite the challenge of obtaining accurate field measurements. Studies have demonstrated that field estimation of core temperature is imprecise. We propose a revision of the original Swiss Staging system. The revised system uses the risk of cardiac arrest, instead of core temperature, to determine the staging level. Our revised system, presented below, simplifies assessment by using the level of responsiveness, based on the AVPU scale, and by removing shivering as a stage-defining sign. The revised system has been accepted by ICAR MedCom. and is available at: http://www.icar-med.com/..

- In the Revised Swiss System, "Alert" corresponds to a GCS score of 15: "Verbal" corresponds to a GCS score of 9-14, including confused patients: "Poinful" and "Unconscious" correspond to a GCS score <9. While shivering is not used as a stage-defining sign in the Revised Swiss System, its presence usually means that the temperature is >30°C, a temperature at which hypothermic CA is unlikely to occur.
- b No respiration, no pulpable caretid or fernoral pulse, no measurable blood pressure. Check for signs of life (pulse and, especially, respiration) for up to 1 min.
- The transition of colours between stages represents the overlap of patients within groups. The estimated risk of cardiac arrest is based on accidental hypothermia being the only cause of the clinical findings. If other conditions impair consciousness, such as asphysia, intextication, high slittude extebral codema or trauma, the revised Swiss System may falsely predict a higher risk of cardiac arrest due to hypothermia. Caution should be taken if a patient remains "alent" or "verbal" showing signs of haemodynamic or respiratory instability such as bradycardia, bradypnosa, or hypotension because this may suggest transition to a stage with higher risk of cardiac arrest.

#### **DRAFTICAR RECOMMENDATION – RESCUER SUMMARY**

Suspension syndrome (also called suspension trauma or harness hang syncope) describes a potentially life-threatening event induced by <u>passive</u> hanging on a rope or in a harness system in a vertical or near-vertical position. Victims can develop symptoms of dizziness or feeling sick, or present with a sudden loss of consciousness and a cardiac arrest. This can occur within 10 minutes of passive hanging. Thus any victim that is passively hanging must be regarded as needing immediate action to relieve it. Although numerous cases are reported, the exact incidence of the suspension syndrome is not known. It is rare because the particular circumstances that cause the cardiac arrest are unusual in normal situations. The cause of the syndrome is controversially though recent experiments have added to our understanding and gave reason to release this recommendation. These recommendations are based on an unanimous consensus opinion of ICAR Medcom. Unusually we are publishing these before a definitive peer reviewed article has been published. We feel this deviation from our normal practice is important for the safety of patients.
