ICAR bylaws with regards to election

According to Article 4.3.1 of the ICAR Bylaws:

4.3.1 Executive Board members are nominated by an ICAR Member organization. The Assembly of Delegates elects the Executive Board for a four-year period. Members may be re-elected twice for the same role. If an Executive Board member takes on a new role, the four-year period starts anew.

In accordance with the ICAR Bylaws, nominations must be received prior to July 23rd, 2021.
